

Special General Meeting held in the Synagogue Chambers Argyle Street on
Sunday, 8th April, 1906 5665-1906 at 11 am.

Present: Mssrs. Samuel Benjamin, President in the chair

George Levy, Isaac Benjamin, Joseph Benjamin, Reuben Benjamin, B. Harris, M.F. Fincker, M. Epstein, A Levian, John Levy and H. Ansell (Hon. Secretary)

Ruled by the Chairman that Mr. Joseph Benjamin be allowed to speak at this meeting and move any resolution having reference to the present position and affairs of the Congregation.

Moved by Mr. John Levy and seconded by Mr. Isaac Benjamin that all those present at this meeting be accepted and enrolled as a member of the Hobart Hebrew Congregation and that an annual subscription of Ten Shillings be paid by each or others desiring to be enrolled to entitle them to such membership. Carried.

Moved by Mr. George Levy and seconded by Mr. M.F. Fincker that the detailed statement of receipts and expenditures together with the balance sheet to date presented and read by the Hon. Secretary, Mr. H. Ansell be received and adopted. Carried.

Moved by Mr. Isaac Benjamin and seconded by Mr M.F. Fincker that this meeting nominate and elect a Treasurer, an Hon Secretary and a Committee of three to form a Governing body in conjunction with the present President or Warden (Mr Samuel Benjamin} four to form a quorum and that the officers and Committee so elected, retain office until the Annual Meeting to be held on or about the last Sunday in August, Carried,

Moved by Mr M.F. Fincker and seconded by Mr. Joseph Benjamin that Mr. Samuel Benjamin be elected Treasurer, such office to be held by him in Conjunction with his present position of President or Warden. Carried.

Moved by Mr M Fincker and seconded by Mr. Geo Levy that Mr H Ansell continue to hold the office of Hon Secretary, Carried.

Moved by Mr. S Benjamin and seconded by Mr. H Ansell that Mssr. Isaac Benjamin and George Levy and MF Fincker be elected Committeemen in accordance with previous resolution, Carried.

Resolved that the Committee compile a code of by-laws for confirmation at the annual meeting.

Moved by Mr. Joseph Benjamin and seconded by Mr John Levy that the secretary write to Mr. SP Lawrence (Queenstown) Mr. Mark Bloch (Delorame) Mr. Philip Cohen (Sheffield) Mrs. Hartnoll and Miss Eliza Fall (Evansdale), Mssr. Steinweker, Glasser and Morris Joseph all of

Launceston, also to Mr. Levy of Peacock and Co, Hobart asking them if they would like to become members of the Hobart Congregation, Carried.

A letter from Mr. J Glasser of 83 Murray Street, Hobart was handed in, wherein Mr. Glasser expresses regret for his inability to attend this meeting and his willingness to become a member of the Congregation. The Hon. Secretary was instructed to reply saying that the Congregation would be pleased to enroll him a member and that the annual subscription was fixed at Ten Shillings

The Meeting closed with a note of thanks to the chairman and to the Hon Secretary.
